- One time membership fee of \$299.00.
- Membership registration is non-transferable.

- It is the Members' responsibility to notify SMP in writing to terminate their membership if/when they leave Sutton.

- Members agree to adhere to all advertising guidelines and specifications as put forth by SMP in preparation of any advertising and marketing material promoting SMP and to request and obtain approval prior to publication.

A written document outlining the compensation structure must be signed by both the member and the broker of record who they represent (who must also be a member) in accordance to the terms of the compensation plan. Fees will be paid out only as long as the individual is with Sutton and a member of SMP in good standing.
- It is the member's responsibility to disclose any fees and/or value received or earned to the consumer, in accordance with all applicable federal, provincial, municipal and real estate board, rules and regulations.
